Invoices 90 days past due are not disputable and are due and payable for goods received and/or services rendered. If Buyer fails to make any payment to Seller when due (NET 30), the Seller may repossess and remove any such product without notice or demand. Furthermore, Buyer is required to assemble the collateral and make it available to allow Seller to take possession of it.
